Important Information

- LINDA M ELGER is the trip leader and **must accompany the entire trip**. Because this river trip does not have any Potential Alternate Trip Leaders, this permit is non-transferable.
- As trip leader you have the responsibility of ensuring that you and all participants comply with the terms and conditions of the river trip permit as stated in the Noncommercial River Trip Regulations.
- You must bring a **paper copy** of ALL the following with you on your river trip: this permit, your trip participant list, and the current Noncommercial River Trip Regulations.
- You are responsible for hauling your trash out of the canyon and to a proper facility. Trash and garbage may not be left at Lees Ferry, Phantom Ranch, Diamond Creek, or Meadview. Only human waste may be deposited at Meadview's human waste treatment plant.
- River trips exchanging participants or taking out at Diamond Creek must contact Hualapai Game and Fish, PO Box 249, 863 Hwy 66, Peach Springs, AZ 86434, 928-769-6043. The NPS shares basic trip information with the Hualapai Tribe for trips exchanging participants or taking out at Diamond Creek.
- For a standard size trip the maximum number of trip participants at any point within the trip is 16.
- Permit fees are nonrefundable.
- Take-out conditions at the Pearce Ferry ramp change regularly. Due to fluctuating water flows and eroding banks, the space available to derig can vary. Please be flexible.
- This permit is revocable at the discretion of the Superintendent or his authorized representative(s). It is issued based on information provided by the trip leader on their noncommercial river trip permit application.
- Before a river trip may launch or travel in Grand Canyon National Park, a pre-trip inspection and education session must be completed by the Lees Ferry Ranger. **Failure to comply with the Lees Ferry check-in procedures or the Noncommercial River Trip Regulations may result in citation or revocation of this permit.** It is the trip leader's responsibility to be sure all members of the trip are familiar with Lees Ferry camping regulations. Permit not valid without signature from Lees Ferry Ranger.

Privacy Act Statement

Authority: 54 U.S.C. §100101, NPS Organic Act; 16 U.S.C. 1131-1136, Wilderness Act; 43 U.S.C. §1701 et seq., 16 U.S.C. §6801-6814, the Federal Lands Recreation Enhancement Act; 36 CFR Part 71, Recreation Fees; 36 CFR 1.6, Permits; and 36 CFR 2.23 Recreation Fees. NPS Backcountry/Wilderness Use Permits may only be issued based on regulations established in 36 CFR §1.6 and §2.10 (outside of Alaska) and in 36 CFR, Part 13 (in Alaska).

Purpose: To establish and verify an applicant's eligibility for a permit to conduct certain activities within the National Park System and to process permits for individual members of the public and organizations interested in obtaining a permit authorizing an activity. Information collected will be used to provide the public and permittees with permit-related information, to monitor activities conducted under a permit, to analyze data and produce reports to monitor the use of park resources, to assess the impact of permitted activities on the conservation and management of protected species and their habitats, and to evaluate the effectiveness of the permit programs. The DOI and NPS may use the information to meet reporting requirements, to generate budget estimates and track performance, and to assist park staff with visitors' education, fee collection, resource management and protection, recreational use planning, law enforcement and public safety personnel for such purposes as emergency contact and search and rescue efforts; to provide permit holders and participants with information about parks and their partners; and to provide reports or activities conducted under an issued permit.

Routine Uses: In addition to those disclosures generally permitted under 5 U.S.C. 552a(b) of the Privacy Act, the National Park Service may disclose records or information to Federal, State, territorial, local, tribal, or foreign agencies to provide information needed to locate an individual or render aid in an emergency; to recover debts owed to the United States; to respond to a violation or potential violation of the law; in response to a court order and/or discovery purposes related to litigation; or other authorized routine use when the disclosure is compatible with the purpose for which the records were compiled.

Disclosure: Voluntary, however, failure to provide the requested information may impede the processing of the Backcountry/Wilderness Use Permit application for the individual member of the public or organization. Deliberately and materially making false or fraudulent statements on this form will be grounds for not granting you a Backcountry/Wilderness Use Permit.
